ORDINANCE 776

AN ORDINANCE PROVIDING FOR THE VACATION OF THE RIGHT OF WAY ADJACENT TO LOT 1, BLOCK 1, RANGE 1 IN THE CITY OF CAMANCHE.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CAMANCHE, IOWA:

Section 1. <u>Purpose</u>. The purpose of this ordinance is to vacate the described right of way as more particularly described in the attached Exhibit "A", which is attached hereto and incorporated herein by this reference, and thereby relieve the City of Camanche, lowa, of the responsibility for its maintenance and supervision of the right of way and enable the City to transfer the right of way to the adjoing property owner, subject to existing easements.

Section 2. Facts Found. The City Council hereby makes the following findings of fact:

- 1) That the described right of way is not needed for the use of the public
- 2) That vacation of said right of way will not deny access to necessary infrastructure of the city or its utility franchise partners
- 3) That the notice of the intended vacation has been published or posted as required by law

Section 3. <u>Vacation</u>. The tract of land previously designated as right of way as described in the attached Exhibit "A" located along the northeasterly portion of Lot, Block 1, Range 1, in the City of Camanche, lowa, be and the same is hereby declared vacated.

Section 4. Repealer. All ordinances or parts of ordinances in conflict with any provision of this ordinance are hereby repealed.

Section 5. <u>Severability Clause</u>. If any section, provision, or part of this ordinance shall be adjudged invalid or unconstitutional, such adjudication shall not affect the validity of this ordinance as a whole, or any section, provision, or part thereof not adjudicated invalid or unconstitutional.

Section 6. When Effective. This ordinance shall be in full force and effect from and after its final approval, passage, and publication as provided by law.
