

ORDINANCE 779

AN ORDINANCE AMENDING THE CAMANCHE, IOWA MUNICIPAL CODE BY AMENDING TITLE 1 CHAPTER 4 OF THE CAMANCHE CODE OF ORDINANCES.

Section 1. **Purpose.** The purpose of this ordinance is to amend the Camanche Municipal Code by modifying the Election Precincts Ordinance as required by Iowa Code 49.7 following a decennial census.

Section 2. **Facts Found.** The City Council of the City of Camanche, Iowa hereby makes the following findings of fact:

1. A Decennial Census was conducted in 2020
2. Language changes are deemed necessary for clearer boundary outlines
3. There are no changes to the previous boundaries other than description
4. An agreement with Clinton County, Iowa is necessary for a certain tract of land and is included in the ordinance

Section 3. **Amendment.** Chapter 1-4 is repealed and replaced with the following language inserted in lieu thereof:

1-4-1 Established and Designated

1-4-1 ESTABLISHED AND DESIGNATED.

1. Precinct 1: All parts of the City lying south and east of the following described line:

Beginning at the westerly-most point where the corporate limits of the City of Camanche intersect with the centerline of U.S. Highway 67;

Thence northeasterly along the centerline of Highway 67 to the intersection of South Washington Boulevard;

Thence easterly and northeasterly along the centerline of South Washington Boulevard to the centerline of 7th Avenue/Central Steel Road;

Thence northerly along the centerline of 7th Avenue/Central Steel Road to the corporate limit on the northwesterly side of the existing rail crossing.

2. Precinct: 2: All parts of the City lying north and west of the following described line:

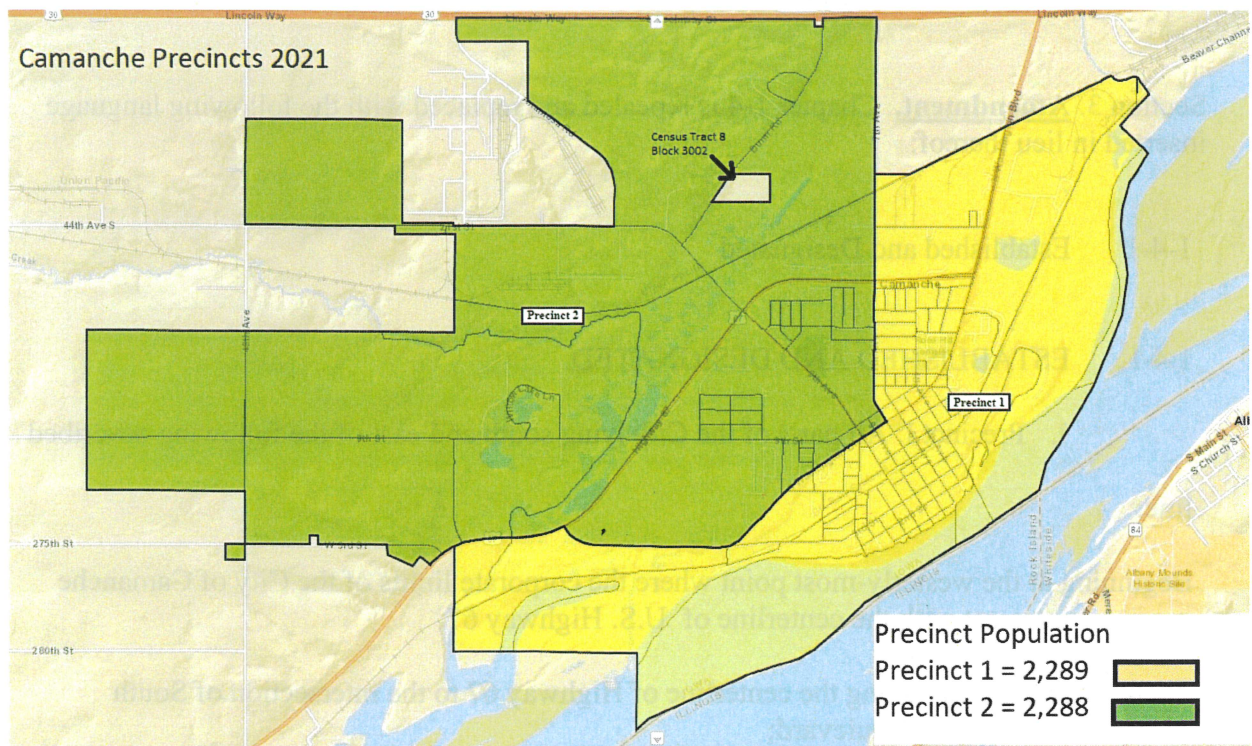
Beginning at the westerly-most point where the corporate limits of the City of Camanche intersect with the centerline of U.S. Highway 67;

Thence northeasterly along the centerline of Highway 67 to the intersection of South Washington Boulevard;

Thence easterly and northeasterly along the centerline of South Washington Boulevard to the centerline of 7th Avenue/Central Steel Road;

Thence northerly along the centerline of 7th Avenue/Central Steel Road to the corporate limit on US Highway 67.

Precinct 2 includes, by agreement between the City Council of the City of Camanche and the Clinton County Board of Supervisors, Census Tract 8, Block 3002.



Section 4. **Repealer.** All ordinances or parts of ordinances in conflict with any provision of this ordinance are hereby repealed.


Section 5. **Severability Clause.** If any section, provision, or part of this ordinance shall be adjudged invalid or unconstitutional, such adjudication shall not affect this ordinance as a whole, or any section, provision, or part thereof not adjudicated invalid or unconstitutional.

Section 6. **When Effective.** This ordinance shall be in full effect from and after its final passage, approval, and publication as required by law.
