THE GENERAL NATURE OF THE WORK IS AS FOLLOWS:

ROADWAY RECONSTRUCTION OF APPROXIMATELY 0.58 MILES OF 9TH STREET IN CAMANCHE FROM HIGHWAY 67 TO EAST OF 19TH AVENUE WITH CURB AND GUTTER, STORM SEWER, AND OTHER APPLICABLE IMPROVEMENTS. THE PROJECT INCLUDES ALTERNATE PAVEMENT OPTIONS OF HOT-MIX ASPHALT AND PORTLAND CEMENT CONCRETE.

EACH BIDDER SHALL ACCOMPANY THE BID WITH A BID SECURITY, IN A SEPARATE ENVELOPE, AS SECURITY THAT THE SUCCESSFUL BIDDER WILL ENTER INTO A CONTRACT FOR THE WORK BID UPON AND WILL FURNISH AFTER THE AWARD OF THE CONTRACT CORPORATE SURETY BOND OR BONDS, ACCEPTABLE TO THE OWNER, FOR THE FAITHFUL PERFORMANCE OF THE CONTRACT, IN AN AMOUNT EQUIVALENT TO ONE HUNDRED PERCENT OF THE AMOUNT OF THE CONTRACT. THE BIDDER'S SECURITY SHALL BE IN AN AMOUNT EQUIVALENT TO 5 PERCENT (5%) OF THE BID AMOUNT, AND SHALL BE IN THE FORM OF A CASHIER'S OR CERTIFIED CHECK DRAWN ON A BANK IN IOWA OR A BANK CHARTERED UNDER THE LAWS OF THE UNITED STATES OF AMERICA, OR A CERTIFIED BANK SHARE DRAFT DRAWN ON A CREDIT UNION IN IOWA OR CHARTERED UNDER THE LAWS OF THE UNITED STATES OF AMERICA OR A BID BOND WITH CORPORATE SURETY SATISFACTORY TO THE OWNER.
