THE BIDDER'S SECURITY SHALL BE IN AN AMOUNT EQUIVALENT TO 5 PERCENT (5%) OF THE BID AMOUNT, AND SHALL BE IN THE FORM OF A CASHIER'S OR CERTIFIED CHECK DRAWN ON A BANK IN IOWA OR A BANK CHARTERED UNDER THE LAWS OF THE UNITED STATES OF AMERICA, OR A CERTIFIED BANK SHARE DRAFT DRAWN ON A CREDIT UNION IN IOWA OR CHARTERED UNDER THE LAWS OF THE UNITED STATES OF AMERICA OR A BID BOND WITH CORPORATE SURETY SATISFACTORY TO THE OWNER.**
