Sealed bids will be opened and publicly read at the City Hall Building 818 7th Avenue, Camanche, IA 52730 at 10:00 AM local time, 11-26-2024 or at such later time and place as may then be fixed.

Bids will be considered by the Owner at a public meeting to be held at City Hall Building 818 7th Avenue, Camanche, IA 52730 at 6:00 PM local time, on 12-03-2024 or at such later time and place as may then be fixed.

The general nature of the work is as follows:

Supply, install, test, and make operational a Base Bid 250 kW Natural Gas powered, or an Alternate 1 Bid 350 kW Natural Gas powered standby generator and associated appurtenances at the Well #5 location at the northwest corner of 4th Ave and 12th Place in Camanche, Iowa. There will be minimal site grading and restoration as shown in the construction documents.

The work must be **READY FOR FINAL COMPLETION** by 12-10-2025 (Base Bid) or 5-21-2025 (Alternate 1 Bid).

The bidder's security shall be in an amount equivalent to 5 percent (5%) of the bid amount, and shall be in the form of a cashier's or certified check drawn on a bank in Iowa or a bank chartered under the laws of the United States of America, or a certified bank share draft drawn on a credit union in Iowa or chartered under the laws of the United States of America or a bid bond with corporate surety satisfactory to the Owner.

It is the intent of the Owner to award a contract based upon the base bid and either alternate(s) that will be in the best interest of the City of Camanche, and the City reserves the right to waive any irregularities in the bids and to reject any or all bids and to determine which is lowest and/or best for the proposed project.
