Under Unfinished Business was an Ordinance Amending the Fireworks Ordinance. City Administrator Kida noted a couple of changes made by legal; adding that people are not allowed to use public property or the right of way to set off fireworks.

Mayor Pruett read the Second Reading, By Title Only, of An Ordinance Amending 3-1-5(6)(a) of the Camanche Code of Ordinances – Fireworks.

Moved by Councilman Klahn, second by Councilman Weller to Approve the Second Reading, By Title Only, of An Ordinance Amending 3-1-5(6)(a) of the Camanche Code of Ordinances – Fireworks. On roll call – Ayes – Councilmembers Edens, Weller, Klahn. Nays – None. Absent – Councilmembers Bowman, Farrell.

Moved by Councilman Klahn, second by Councilman Weller to Waive the Third Reading of An Ordinance Amending 3-1-5(6)(a) of the Camanche Code of Ordinances — Fireworks. On roll call — Ayes — Councilmembers Edens, Klahn, Weller. Nays — None. Absent — Councilmembers Farrell, Bowman.

Moved by Councilman Edens, second by Councilman Weller to Adopt An Ordinance Amending 3-1-5(6)(a) of the Camanche Code of Ordinances – Fireworks. On roll call – Ayes – Councilmembers Edens, Klahn, Weller. Nays – None. Absent – Councilmembers Bowman, Farrell.

Also under Unfinished Business was a Resolution approving the Amended Capital Improvement Plan. Councilman Klahn commented that we did not even talk about Fareway being included in the CIP. Kida said, other than the road it wouldn't be our capital. The road

could be, but it will be paid from the Road Use Fund and he would put that in the Street Improvement Plan. We really do the CIP as a way to organize and direct when debts come on. Klahn asked about 1st Street being on the CIP; Kida said yes, it is expected that we are going to take on a debt to do that. Klahn asked where the money Fareway wants is going to come from; Kida said we will have to figure that out at that point. Kida said Fareway is really Economic Development. Councilman Weller added that the CIP is plan of things we are going to do and Fareway doesn't really fit. It is basically a guideline and not set in stone. We can revisit it and amend it in the future if we need to.

Moved by Councilman Weller, second by Councilman Edens to Adopt a Resolution approving the Amended Capital Improvement Plan. On roll call – all Ayes.

Under New Business, a Service Agreement with Next Level Response Solutions, LLC was discussed. It is a panel of Fire Chiefs from around the state with no preconceived notions of the candidates to run an assessment for the candidates for our next Fire Chief. We can tailor make the questions and it will be similar to when Chief Schutte was hired.

Moved by Councilman Klahn, second by Councilman Weller to Approve Service Agreement with Next Level Response Solutions, LLC for an assessment center panel to rank applicants for the position of Fire Chief in the amount of \$4,635.00. On roll call — all Ayes.

Mayor Pruett read a Resolution Establishing the Level of Compensation for the Employees of the City of Camanche for FY 2026 to ratify the levels of compensation the City's Negotiating Committee negotiated.

Moved by Councilman Weller, second by Councilman Klahn To Adopt a Resolution Establishing the Level of Compensation for the Employees of the City of Camanche for FY 2026. On roll call – all Ayes.

Moved by Councilman Edens, second by Councilman Weller to Adopt a Resolution Setting the Time, 6:00 p.m., and Date, July 1, for a Public Hearing for the sale of real estate between the City of Camanche and Steven E. Reckman and Susan K. Reckman locally described as 1,236 square feet consisting of approximately a 20' strip of City owned land (part of Clinton County Parcel No 1000920500) adjacent to the Buyer's property at 821 1st Street. On roll call—all Ayes.

Moved by Councilman Edens, second by Councilman Weller to Adopt a Resolution Setting the Time, 6:00 p.m. July 1, and place, Camanche City Hall, for a Public Hearing for the Vacation of 1,236 square feet consisting of approximately a 20' strip of City owned land (part of Clinton County Parcel 1000920500) next to 821 1st Street. On roll call – all Ayes.

Chief Schutte informed Council that the State Legislature just set aside \$1.5 million for the lowa Firefighters Association Length of Service Award Program. He is seeking Council approval to register our department for participation in the program. The maximum per volunteer is \$500 per year and it is a \$1 for \$1 match and the criteria for earning the award are

set by each department. Councilman Klahn asked if Schutte knew what the numbers are; he said those with 5 years of service, so approximately 20 people, and probably 10 would meet the criteria, so maybe \$5,000 annually. Mayor Pruett said it will be nice to be able to do this.

Moved by Councilman Edens, second by Councilman Klahn to Authorize Chief Schutte to Register for Participation in Length of Service Award program for Volunteers. On roll call – all Ayes.

Chief Schutte presented the May 2025 Camanche Fire Department report and Chief Schmitz presented the May 2025 Camanche Police Department report.

Kida reported that three Councilmembers, the Planning and Zoning Commission had a meeting about the Land Use Plan with some citizens in attendance. We are also in the process of doing the Fareway site review. IMON has paid their boring permit and an invoice has been sent for the Solar Project permits so have been able to recoup some of our expenses via these fees.

Councilman Klahn had a question regarding the 9th Avenue Culvert. In May of 2022, it was emergent and it is just now being done. Mayor Pruett said we had some difficulty with easements on both sides. City Engineer Solchenberger said we shortened the pipe to keep it within the right of way so we needed only a temporary easement so we could move forward. He and Pewe also assured everyone that Public Works staff were watching this area very closely since the issue was identified and would have closed the road if the condition had deteriorated. Klahn also asked about the Splash Pad hours. Kida recommends 10:00 a.m. until 8:00 p.m. and will talk to the Park and Recreation Commission. Public Works Director Pewe reported that the 9th Avenue repairs are in process. The permanent generator at Well #5 has been set and his department had training on it today. There will be a fence installed around it. Interior cleaning of water tower #2 was done. An offer has been made to a candidate for the Cemetery Sexton/Public Works position. Councilman Weller mentioned that some people have been taking advantage of the yard waste drop off, leaving construction materials and also dropping off yard waste outside of designated hours. Councilman Klahn asked if there is a game plan on 12th Place. Kida said only part of that is our property; the north side is the park and the south side belongs to the resident. We will pay our portion and the resident will pay their portion if the resident chooses to have the work done. Chief Schmitz said the 501c3 is having a Touch a Truck event on 6/29/25, 1:00 p.m.-3:00 p.m. at the High School with MedForce, Police, Fire, a crane; a concrete truck and many more; it is a fundraiser.

Mayor Pruett called for Public Comments. Marshall Richardson, 103 5th Avenue, spoke about the grounds at the 5th Avenue boat ramp. The weeds and overgrowth are getting really bad. The City has a grass cutting Ordinance and he can't believe the City wouldn't have something for that too. Also, 1st Street, from the flood, or what is left, it is really horrible down there right now. He requests that the Council drive by and get out of their cars and actually see just what the condition really is. That was his main issue. His second issue is the City spent a lot of money for that ramp, to fill that in, when there was nothing there; built the ramp, the whole nine yards. Right now, the whole image of this is for a fishing dock. Money was left to

the City for a fishing dock, they found it, a good place to put it. There's no boat dock and since there's not boat dock there, there's no boating. It's so shallow in there, most of the time you can't float all the way up into shore to get out without getting into mud or sand or whatever. We really need a boat dock they can use. They float that dock in front of me, this guy's rock, for his commemorative rock at 7th, the park there, I don't know why they couldn't just try it. Anyway, I would really appreciate it if you could take yourselves down and look at the conditions down there and consider a boat dock down there so boaters can use it. It is the entrance to Camanche from the river and can't even use it. I appreciate you for hearing me.

Randy Goldbeck, 512 2nd Street, said he read all of the documentation on our website and noticed there was an external financial audit report done in June of 2022. Schneider said yes, we have an audit done every year; Kida said he will post the rest. On page 41 of the report, it mentioned an anomaly about segregation of duties. Kida responded by saying when we had only three people working in City Hall, we did not have enough staff to segregate the duties. That was part of the function of hiring an Administrative Assistant. The original intention was going to monthly billing because it would create more work, but that other person also does additional function, giving us the proper segregation of duties. We have now been able to remove that comment from our audit. Mayor Pruett added that we have a Finance Committee as a part of Council who reviews and signs off on all transactions as well.

There were no additional public comments.

Mayor Pruett asked for requests from Councilmembers for items for future Agendas. There were no requests at this time.

Mayor Pruett adjourned the meeting at 6:50 p.m.

3-10-1 PURPOSE. The purpose of this chapter is to protect the health, safety, and welfare of the citizens and safety of property of this City by providing for removal of abandoned motor vehicles and the elimination of the open storage of abandoned and junk motor vehicles and machinery except in authorized places.

(Code of Iowa, Sec. 3641.1)

- 3-10-2 DEFINITIONS. For the purpose of this chapter, the following terms are defined as follows:
 - 1. "Abandoned vehicle" means any of the following:
- a. A vehicle that has been left unattended on public property for more than twenty-four hours and lacks current registration plates or two or more wheels or other parts which render the vehicle inoperable; or unsafe or
- b. A vehicle that has remained illegally on public property for more than twenty-four hours; or
- c. A vehicle that has been unlawfully parked on private property or has been placed on private property without the consent of the owner or person in control of the property for more than twenty-four hours; or
- d. A vehicle that has been legally impounded by order of the Chief of Police and has not been reclaimed for a period of ten days; or
- e. Any vehicle parked on the street determined by the Chief of Police to create a hazard to other vehicular traffic.

(Code of Iowa, Sec. 321.89(1)(b))

- 2. "Private property" means any real property within the City which is not public property as defined in this section.
- 3. "Public property" means any public right-of-way open for the purposes of vehicular travel.
- 4. A "junk vehicle" means any vehicle without current license plates or which has any one of the following characteristics:
- a. Any vehicle with a broken or cracked windshield, or window or headlight or any other cracked or broken glass.
- b. Any vehicle with a broken or loose fender, door or bumper or hood or door handle or window handle or steering wheel, trunk top or trunk handle or tail pipe.
- c. Any vehicle which has become the habitat of rats, mice, or snakes, or any other vermin or insects.

- d. Any motor vehicle if it lacks an engine or two or more wheels or other structural parts which render said motor vehicle totally inoperable.
- e. Any other vehicle which, because of its defective or obsolete condition, in any other way constitutes a threat to the public health and safety.

(Cedar Falls v. Flett 330 N.W. 2nd 251, 253, Iowa 1983)

5. "Vehicle" means every device in, upon, or by which a person or property is or may be transported or drawn upon a highway or street, excepting devices moved by human power or used exclusively upon stationary rails or tracks, and shall include without limitation a motor vehicle, automobile, truck, trailer, motorcycle, tractor, buggy, wagon, farm machinery, or any combination thereof.

3-10-3 REMOVAL OF ABANDONED VEHICLES.

- 1. The Chief of Police or Mayor may, without prior notice or hearing, remove and impound any abandoned vehicle as defined in section 3-10-2 (1). The Chief of Police or Mayor may hire other personnel, equipment, and facilities for the purpose of removing, preserving, storing, or disposing of abandoned vehicles.
- 2. The impoundment and storage of all vehicles pursuant to this chapter shall be in such areas or places designated by the City Council.
- 3. When a vehicle is taken into custody and impounded under the provisions of this chapter, the Chief of Police or Mayor if the Chief of Police is unavailable, shall maintain a record of the vehicle, listing the color, year of manufacture, manufacturer's trade name, body style, vehicle identification number, and license plate and year displayed on the vehicle. The records shall include the date and hour of tow, location towed from, location towed to, person or firm doing the towing, reason for towing, and the name of the officer authorizing the tow.

(Code of Iowa, Sec. 321.89(2))

4. Nothing in this chapter shall govern the procedures of any police officer in taking into custody and impounding any vehicle to be used or proposed to be used as evidence in a criminal case involving crimes other than violations of this chapter.

3-10-4 NOTIFICATION OF OWNERS AND LIENHOLDERS.

1. When a vehicle is taken into custody under the provisions of this chapter or under any provisions of State law, the Chief of Police or Mayor if the Chief of Police is unavailable, shall notify, within three days, by certified mail with five-days return receipt, the last known registered owner of the vehicle, all lienholders of record, and any other known claimant to the vehicle or to personal property found in the vehicle, addressed to their last known addresses of record, that the abandoned vehicle has been taken into custody. Notice shall be deemed given when mailed. The notice shall:

- a. Describe the year, make, model, and serial number of the vehicle.
- b. Describe the personal property found in the vehicle.
- c. Describe the location of the facility where the vehicle is being held.
- d. Inform the persons receiving notice:
- (1) of their right to reclaim the vehicle and personal property within ten days after the effective date of the notice;
- (2) that the right can be exercised upon payment of all towing, preservation, notice, and storage charges resulting from placing the vehicle in custody;
- (3) that failure of the owner or lienholders to exercise their right to reclaim the vehicle within the reclaiming period shall be deemed a waiver by the owner and all lienholders of all right, title, claim, and interest in the vehicle;
- (4) that failure to reclaim the vehicle is deemed consent to the sale of the vehicle at a public auction or disposal of the vehicle to a demolisher.
- e. State that any person claiming rightful possession of the vehicle or personal property who disputes the planned disposition of the vehicle or personal property by the Chief of Police or the assessment of fees and charges provided by this chapter may request a hearing to contest these matters in accordance with the provisions of Section 3-10-6.
- f. State that a request for a hearing must be in writing and received by the department prior to the expiration of the ten day reclaiming period.
- g. State that in the event a hearing is requested immediate release of the vehicle may be obtained by posting a cash bond as required by Section 3-10-5.

(Code of Iowa, Sec. 321.89(3)(a))

2. The owner, lienholders or any person receiving notice may, by written request received by the Chief of Police prior to the expiration of the ten day reclaiming period, obtain an additional fourteen days within which the vehicle may be reclaimed.

(Code of Iowa, Sec. 321.89(3)(c))

- 3. Notice by one publication in one newspaper of general circulation in the area where the vehicle was abandoned shall be sufficient to meet the requirements of this chapter. The published notice may contain multiple listings of abandoned vehicles but shall be published within the same time requirements and shall contain the same information as prescribed for mailed notice in this section. Published notice shall be used if:
 - a. the identity of the last registered owner cannot be determined, or

- b. the registration contains no address for the owner, or
- c. it is impossible to determine with reasonable certainty the identity and address of all lienholders.

(Code of Iowa, Sec. 321.89(3)(b))

- 4. If the persons receiving notice do not request a hearing or exercise their right to reclaim the vehicle or personal property within the reclaiming period, the owner of the vehicle or owners of the personal property shall no longer have any right, title, claim, or interest in or to the vehicle.
- 5. No court in any case in law or equity shall recognize any right, title, claim, or interest of the owner and lienholders after the ten day reclaiming period.

(Code of Iowa, Sec. 321.89(3))

3-10-5 IMPOUNDMENT FEES AND BONDS.

- 1. Before the owner or other person lawfully entitled to possession of any vehicle that has been impounded under the provisions of this chapter or any other provision of law may recover such vehicle, such person shall present to the Chief of Police or Mayor if the Chief of Police is unavailable, evidence of such person's identity and right to possession of the vehicle, shall sign a receipt for its return, and shall pay the costs of:
 - a. an impoundment fee
 - b. towing charges
 - c. preservation charges
 - d. storage charges
 - e. notice charges

(Code of Iowa, Sec. 321.89(3)(a))

- 2. The amount of the charges specified in a-e shall be set by a Resolution adopted by the City Council. The notice charges shall be limited to the actual cost.
- 3. If a hearing is requested under Section 3-10-4 (1)(e), the owner or person lawfully entitled to possession of the vehicle shall be permitted to secure the immediate release of the vehicle upon posting a cash bond in an amount equal to the sum of:
 - a. the fees required by Section 3-10-5(1)
- b. the amount of the fine or penalty for each violation for which there is an outstanding or otherwise unsettled traffic violation notice or warrant.

ORDINANCE	

AN ORDINANCE PROVIDING FOR THE VACATION OF 1,236 SQUARE FEET OR APPROXIMATELY A 20' STRIP OF LAND MORE COMMONLY KNOWN AS CHICAGO STREET PARK ADJACENT TO 821 1ST STREET IN THE CITY OF CAMANCHE.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CAMANCHE, IOWA:

Section 1. <u>Purpose</u>. The purpose of this ordinance is to vacate the described right of way as more particularly described in the attached Exhibit "A", which is attached hereto and incorporated herein by this reference, and thereby relieve the City of Camanche, Iowa, of the responsibility for its maintenance and supervision of the property and enable the City to transfer the right of way to the adjoining property owner.

Section 2. Facts Found. The City Council hereby makes the following findings of fact:

- 1) That the described property is acceptable to sell in exchange for consideration on another piece of property in the possession of the owners
- That vacation of said right of way will not deny access to necessary infrastructure of the city or its utility franchise partners unless otherwise specified under easement agreements as deeded
- 3) That the ownership of the secondary consideration is necessary for public infrastructure needs
- 4) That the notice of the intended vacation has been published or posted as required by law

Section 3. <u>Vacation</u>. The tract of land previously designated as right of way as described in the attached Exhibit "A" located along the northeasterly side of 34-81-06PRT VAC 9TH AVE S OFS/L 1ST ST. more commonly known as Chicago Street Park being and the same is hereby declared vacated.

Section 4. Repealer. All ordinances or parts of ordinances in conflict with any provision of this ordinance are hereby repealed.

Section 5. <u>Severability Clause</u>. If any section, provision, or part of this ordinance shall be adjudged invalid or unconstitutional, such adjudication shall not affect the validity of this ordinance as a whole, or any section, provision, or part thereof not adjudicated invalid or unconstitutional.

Section 6. When Effective. This ordinance shall be in full force and effect from and after its final approval, passage, and publication as provided by law.


